ROAD MASTER REPORT- John Berry gave an update on the roads for the past month. Road Crew spent a good part of the month milling and patching River Hill and Fitzkee Rd. Cleaned and repaired gutters on River Hill and River Rd. Cut and cleaned trees up after storm on Sandhill and Shenks Ferry. Patched pot holes on Green Hill and Shenks Ferry Rd. Replaced side wall and signs on bridge on Stoney Lane. Cut, removed trees, cleaned rain gutters and parking lot in front of Twp office. Mowed rail trail and cleaned leaves off of Trestle Bridge. Sealed cracks on various roads throughout the Twp. Inspected 550, replaced teeth on milling head. Also put plows and salt spreaders on trucks, winterized the roller and performed general maintenance of equipment.
