Eric would like to know what the status is for repairing the trestle bridge, the Board stated that the bridge is currently stabilized and the DCNR grant that is currently being applied for would help with moving forward on the restoration of the bridge.

Terry Shepps stated that the budget for the Township is looking good and the funds are continuing to grow.

Berry informed everyone that the Township has received a grant from the Lancaster Bicycle Club for \$1,976.00 for the purchase of 2 bike racks and a picnic table for the Enola Low Grade Rail Trail.
