Conestoga Township B.O.S Minutes April 2nd 2019

CALL TO ORDER- The Supervisors meeting was called to order at 7pm by Berry.

PRESENT- Supervisors, John Berry, Robert Hershey Jr. and William Rankin, Secretary Naomi Little, Citizens; Attendance list attached.

MINUTES- The Supervisors approved the March 2019 BOS meeting Minutes on a motion by Rankin, second by Hershey Jr. One correction was made to the name Eric Anderson. All in favor none opposed.

BILLS- The Supervisors approved all bills paid during the month of March on a motion by Hershey Jr., second by Rankin. All in favor none opposed.

EXECUTIVE SESSION held March 5th from 7.15-7.49 to discuss strategy for upcoming arbitration meeting. TREASURER'S / ZONING & STATE POLICE REPORT - On front table and filed in office for review. Lieutenant Vince D'Angelo was present to take any questions and give an overall report for the year of 2018. He said that the stats were looking good, low and not much serious crime. For the most part a pretty quiet year compared to what they see across the state.

GENERAL PUBLIC

Scott Kriner inquired about the handicap access to the Trail, The Board stated that it will be worked on by the Boyscouts and be at the Colemanville entrance.

Robin Maquire expressed her dissatisfaction with the details in the minutes; the Board explained that the minutes taken are adequate and to PSAT standards.

Linda Lyke asked the Lieutenant what area where the burglaries that took place? Lieutenant D'Angelo stated that the stats were pulled from the Township as a whole and there were only 3 for the year.

Ben Vonderheide asked what the stats were from the prior year. Lieutenant D'Angelo stated he did not have the 2017 stats. Ben asked for the Board to look into it and the Board said they would see what they could do.

Lydia Martin commented that there are some grants to look into that may be available to apply for to help with the Trestle Bridge repairs. She also stated that she would like to see the master site plan or comp plan updated in the future. Berry stated this would be something the Township would like to look into for the future.

Berry stated that the Wild Flower Preserve has been vandalized with 4 wheeling and the Road Crew is working on fixing up the damage and looking to work with the Conservancy to have gates put up to stop further damage.

Wes Bruckno commented that it might be helpful to contact climbers that are using the trail to assist in watching out and reporting vandalism on the Rail Trail.

OLD BUSINESS:

ROAD BIDS- Sealed bids were opened at the meeting. Longs Asphalt was awarded the 2019 Conestoga Township Road project. The project will be for Stone Hill Road starting at Stone Hill Rd. and Main Str. ending at Stone Hill Rd. and Long Ln. Motioned by Berry, second by Rankin. All in favor none opposed. The bids were as follows:

NEW BUSINESS:

GRANTS - Berry informed the Residents about a joint DCED grant for the Rail Trail for \$750,000.00 that Conestoga and Martic Townships will be receiving. This will help with restoring the Trestle and also possibly assist with the match grant with DCNR to get us to the goal of 2 million.

Conestoga Township also received a grant from the Conservation District for Green Hill Road in the amount of \$10,668.00 to repair and drainage issues.

FRED WARFEL- The Board informed the Residents that a tree was planted at the Township in honor of a beloved Resident, Ambulance service provider, and Volunteer Fire Fighter, Fred Warfel. Fred was a true example of a friend and neighbor who was active in supporting and caring for his community and it was apparent in every aspect of his life. On behalf of Conestoga Township the Board would like to thank Fred and Doris Warfel for their amazing efforts in the community over the years with the ambulance service and overall community involvement to help enrich the Township and its Residents.
