Terry Shepps asked if there is still a possibility to pursue the equipment reimbursement. Berry said a letter has been sent to Pequea inquiring about the funds being released to Conestoga.

Terry Shepps gave a report of the Townships financial status, he stated that the Twp. is at a positive status, organized and revenue is up. There is no deficit spending and the Twp. is in good shape, making advanced repayment of debt for new equipment and good budgeting for road repairs and maintenance.

Woodcrest Rd.-leveling and wearing course.

Rock Hill Rd. Intersection-leveling and wearing course.

Roads will also get pipe replacement and address drainage issues.

Adams Subdivision – Approved contingent on a sketch plan to be submitted along with addressing all comments from the Township Engineer, County and Conservation District. Motioned by Berry, second by Hershey Jr. All in favor none opposed. Craig Smith with RGS Associates presented the project for the property to be broken into 4 lots. He proposed for project to be put into the preliminary/final stage.

Employee evaluations- Motion by Berry, second by Hershey Jr. to appoint Bill Rankin to review employees and do evaluations for the year.

Fire Co. Report- Fire Chief Larry Frankford gave a review the Fire Company for the year. He stated that the Fire Company has applied for a grant to help fund the purchase of new pagers that will be needed at the end of the year. The pagers they currently have are on a low frequency and will be obsolete at the end of December. It will be required for them to have a pager that works off of a high frequency, these pagers cost are at \$625.00. The Fire Co. is doing their best to fund these new pagers for the Volunteers. Also the Fire Co. is currently looking for Volunteers that would be able to help out in the day time, Volunteers are much needed and appreciated, this would help the Twp. Fire Co. to be available for day time calls and get a truck out on the scene. The Fire Co. will be having two fund raisers; a Spring Dance at the Millersville VFW from 6-11 on March 7th and a Gun Raffle from 1-5 on June 6th. Tickets are available for sale for the gun raffle, anyone who is could help sell these tickets would be a great help.
