A RESOLUTION OF THE TOWNSHIP OF CONESTOGA, LANCASTER COUNTY, PENNSYLVANIA, ACCEPTING A PORTION OF GRANDVIEW LANE AND NATURES WAY, LOCATED IN THE GREEN HILL ESTATES SUBDIVISION, AS PART OF THE PUBLIC ROAD SYSTEM OF CONESTOGA TOWNSHIP.

WHEREAS, a plan of a portion of Grandview Lane and Natures Way located in Green Hill Estates, Phase III, subdivision, has previously been submitted to and approved by the Board of Supervisors of Conestoga Township; and

WHEREAS, a portion of Grandview Lane and Natures Way, located in Green Hill Estates, Phase III subdivision, have been constructed in accordance with such approved plan which was recorded in Subdivision Plan Book J-203, Page 114 and Subdivision Plan Book J-185, Page 139, respectively, in the Recorder's Office in and for Lancaster County, Pennsylvania.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Supervisors of Conestoga Township, Lancaster County, Pennsylvania, as follows:

1. A portion of Grandview Lane, as described in Exhibit "A" which is attached hereto and incorporated herein by reference, shall be and hereby become a part of the public road system of Conestoga Township.

2. Grandview Lane begins at Station 14 + 14.49, ends at the northerly righty-of-way line of Natures Way, is 1,291.68 feet in length and has a righty-of-way width of 50 feet and a cartway width of 24 feet.

3. Natures Way, as described in Exhibit "B" which is attached hereto and incorporated herein by reference, shall be and hereby become a part of the public road system of Conestoga Township.

4. The portion of Natures Way begins at Station 8 + 22.49 and ends at the terminus of the temporary cul-de-sac, is 715.84 feet in length, and has a right-of-way width of 50 feet, and a cartway width of 24 feet.

5. A draft of a portion of Grandview Lane and Natures Way is attached hereto as Exhibits "A" and "B" and made a part hereof, in accordance with Section 2316 of the Second Class Township Code.

6. The proper officials of the Township are hereby authorized to do and perform all acts necessary and required under the Second Class Township Code and the Act of Assembly Allocating Fuel Taxes to Municipalities (72 P.S. 2615.1, et seq.) to accept such streets as part of the public road system of Conestoga Township.
