BOS Meeting called to order at 7pm by Berry

PRESENT-Supervisors; Chairman John Berry, Vice Chair William Rankin and Member Robert Hershey Jr. Secretary Naomi Little Citizens; attendance list attached.

MINUTES- The Supervisors approved February 2021 BOS Meeting Minutes on a motion by Hershey Jr. second by Rankin. All in favor none opposed.

GENERAL PUBLIC

Tina Clare-Inquired about the pool for this season.

The Board stated that due to the ongoing pandemic and issues with Pa having a slow roll out of vaccinations they have done a lot of research and reaching out to the many departments such as the CDC, Dept. of Health and Governor's Office to review and discuss the safest way to approach the issue. After much review and study of the CDC guidelines with the Director for the Department of Health the Board has been advised that if the guidelines cannot be followed and enforced as directed that it would not be safe for the pool to open this season. The Board has done extensive remodeling to the Pool over the last year and was looking forward to opening but with the CDC guidelines as they are it would be impossible to enforce.

Robin Maquire- Asked why are other pools opening and demanded that the Township open the pool. The Board stated that other surrounding pools are privately owned and the Township being local government is held to a different standard and must abide by the state guidelines. The Board asked her to remain calm and reprimanded her for her disruptive behavior.

Ray Clare- Asked what will be done on Elm Street. The Road Master said that 1150 feet of base repair will be done with petro mat and leveling / wearing course.

Christine Connely- Commented about how it would be impossible to enforce the CDC guidelines with the pool. She also asked if it would be better for the Community if it were to be privately run. The Board stated that this would be something to look into for the future.
