### GENERAL PUBLIC

**Dave Clancy** asked that the Township not include a property maintenance ordinance because he thinks that the Township should not have authority over resident's property. He would also like the Township to have more information available to residents about the new covid grant. He also would like to know about the pool maintenance over the last two years it has been closed.

**Berry** stated that the pool is winterized and he is still adding chemicals, running the pumps, and the water is shut down with heat tape on the pipes. Berry said his CPO licenses will be up this year and he is undecided if he will be renewing it.

**Hershey Jr.** asked about finding someone to do the pool testing.

Berry stated the pool and spa place has CPO certified people that could be hired to do the testing.

**Bill Rankin** stated that if people are interested in having the pool they should look into getting a group together to volunteer and run it.

**Paul Thomas** stated that it is a tough job maintaining the pool chemicals and following all the regulations.

**Hershey Jr.** informed the public about the Safe Harbor park issue with Brookfield Renewable. Brookfield is having multi lingual signs put up through the park and increased security with Schaad. He also provided phone numbers for Brookfield's HR department and the 24 hour security number for Schaad. The Board will continue to work with Brookfield to resolve the issues.

**Doman** stated that he would like to see more people come out to the meetings and get involved so that they are informed and educated themselves on the Township and work together.

**Doris Warfel** thanked the Board for all the hard work they have done getting grants.

**Berry** stated that the Township has several grants that have gone into the Township roads, road way pipe replacement, equipment purchases, and the Rail Trail.

**Terry Shepps** stated that the Township's budget is healthy, well managed and he appreciates that the Board is maintaining it successfully.

**Christine Connelly** informed the public that there was a petition for a 5 member board circulated and could possibly be on the next election ballad.

**Robin Maquire** stated that there is water shed issues on Sand Hill Road.

**Berry** explained that the gutter will be cleaned out and the road will need to be paved eventually.

**Bonnie Yowler** inquired about speeding towards Safe Harbor.

**Berry** informed her that the State Police are working on the speeding issues and have been setting speed traps throughout the Township.
