Lancaster EMS- Bob May was presented with donations from private and local business for help with the funding issues that he has brought up at the November meeting totaling in \$5,000.00. The Board approved for the Township to give \$2,000.00 to Lancaster EMS and also provide \$7,000.00 to the Conestoga Volunteer Fire Company contingent on approval from the Township Solicitor that the Township may do so. These funds will be taken from the Covid Relief funding the Township has received. Motioned by Berry, second by Hershey Jr. All in favor none opposed. The Board explained that the Ambulance Co. is very important to the

Township and wanted to help out but the Township wants to have Mr. May back at April's 2022 BOS meeting to inform the Board on how it is doing and what procedures they have put in place to help prevent the problems that the Ambulance Co. is having now.
