BOS Meeting called to order at 7pm by Secretary Little

PRESENT-Supervisors; Vice Chair Eric Doman, Member Robert Hershey Jr, Citizens; attendance list attached.

Ray Clare asked about the certification fees. The Board stated that any information that is available will be put on the website for everyone to review and get informed.

Doris Warfel asked if the pool could be leased out to get it out from under the Township due to the large amount of liability involved. The Board agreed that it would be a good option.

Hershey Jr. and Doman thanked the Residents for speaking with them about the situation at hand and stated that they are here for the Residents and looking forward to working with the Community to come up with the best solution for everyone.
