Umbrella Liability	\$1,000,000
(If no Umbrella Liability is carried, then adding Conestoga Township as an additional Insured in the General Liability will suffice.)	

2. Attach a copy of License issued by the State of Pennsylvania and a copy of registration with the Attorney Generals Office showing expiration date.
3. Attach a copy of Explosives sales permit showing expiration date.
4. Attach a list of the number and kinds of fireworks to be discharged.

This permit when signed by an authorized Official of Conestoga Township shall serve as evidence of the permit being issued and shall be in effect as of date signed by such Official.

If by reason of unfavorable weather the display for which a permit has been granted does not take place at the time so authorized, the person to whom such permit was issued may within 24 hours apply to the authority having granted the same, setting forth under oath the fact that such display was not made, giving the reason therefor, and requesting a continuance of such permit for a day designated therein, not later than one week after the day fixed originally in said permit. Upon receiving such application for a continuance the said authority, if it believes the facts stated therein are true, shall extend the provisions of said permit to the day fixed in said application, not later than one week after the original day designated in the permit, and such extension of time shall be granted without the payment of any additional fees using all information given on the original permit.
